
### **RELATIVE INTENSITY vs. WAVELENGTH**





### **SPATIAL DISTRIBUTION**













# **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**




### Notes:




# **REEL DIMENSION** (units: mm)
